Waiver and Release of Legal Rights & Indemnification

In consideration for permission to participate in activities of Grand Canyon Hounds, Inc., and Macarco VII, LLC, doing business as Grand Canyon Stables, the undersigned agrees to the following waiver and release of legal rights:

1. Limited Permission: I understand and agree that this permission is granted to allow me to participate in: (i) staging equestrian activities; (ii) participating in equestrian activities; and (iii) spectating while at equestrian activities. I agree to limit myself to these activities and no others.

2. Acknowledgment of Risk: I know that the sport of horseback riding and other activities involving the use of horses and hounds, including but not limited to fox hunting, trail riding or schooling, horse training, riding, horse shows, point-to-point racing, pairs racing and hunt club team racing, are athletic events which are, potentially, dangerous activities [the "Activities"]. I also know that horses and hounds can behave in unpredictable and dangerous ways. Horses and hounds can be provoked by unanticipated sources (such as noise, movement and dangerous creatures). I also know that, should I participate in events or activities of the Grand Canyon Hounds, Inc., or Macarco VII, LLC, I can expect to face hazards and risks associated with both the Activity and the conditions of the property and terrain, including rocks, ruts, roots and ravines, loose and wet earth, slippery, icy and snow-covered conditions, fences, jumps and obstacles, brush and trees, and dangerous animals and reptiles. I can and will face choices involving risk to my person and property that can result in my death or serious injury, and damage to my property.

3. Release: Having considered all the risks to my person and my property, whether those risks are known or unknown, foreseen and unforeseen, future or contingent, I voluntarily agree to forever release Grand Canyon Hounds, Inc., and Macarco VII, LLC, its officers, directors, partners, members, employees, volunteers, lessees, guests, invitees, licensees, and agents, along its event sponsors, and any and all landowners, permitors, licensors, and all others who have granted Grand Canyon Hounds, Inc., and Macarco VII, LLC, an access to conduct events [hereafter the "Released Parties"] from any and all liability and claims of injury, damage and harm of whatever kind and nature, however caused, including, without limitation, resulting from the negligence or other acts of any of the Released Parties.

4. Covenant Not To Sue: I agree that I shall never bring, commence, prosecute, or participate in any action, suit or other proceeding against the Released Parties arising out of, concerning, or related to, participation in the Activities as defined above, or actions and omissions of the Released Parties, including, without limitation, the negligence, of the Released Parties.

5. Authority; Binding Effect: I have full power, authority, capacity, and right, without any limitation, to execute, deliver and perform this Agreement. This Agreement shall be binding upon me and my spouse, legal representatives, heirs, successors, and assigns, and shall inure to the benefit of the Released Parties. This Agreement shall be governed by the laws of the State of Arizona. If, for any reason, any provisions of this Agreement shall be determined by a court of competent jurisdiction to be invalid, unenforceable, illegal, or inoperable, I agree that its invalidity shall not affect the validity and effect of the other provisions herein.

6. Helmet and Protective Gear: I am advised to wear a helmet and protective gear for my own protection. I have checked the box indicating my understanding of this advice.
